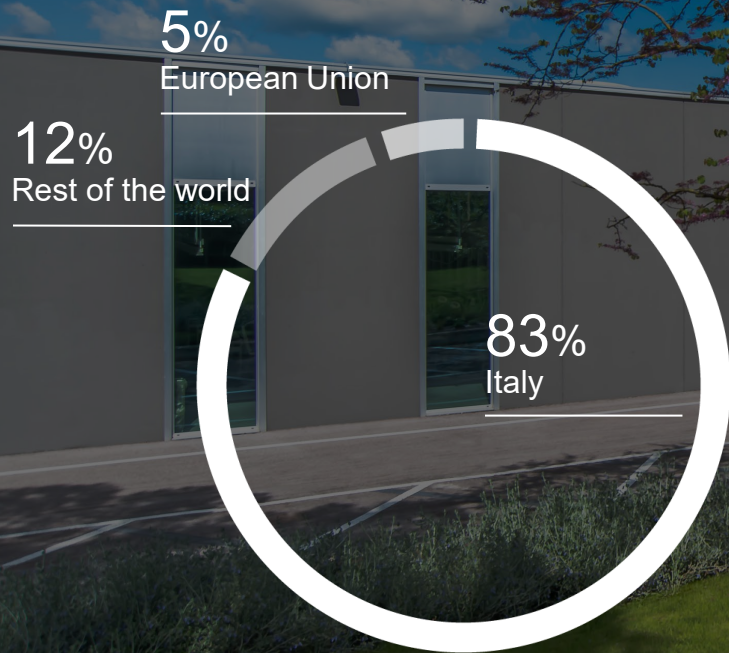

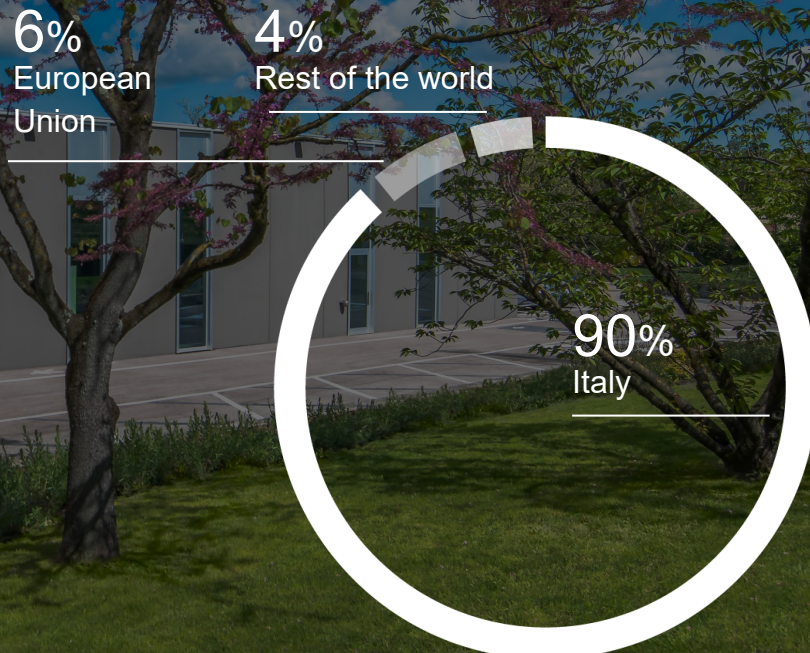

Development of the Torgiano knitwear hub

The Torgiano facility is the knitwear hub for Prada Group

It is where finished knitwear and semi-finished knits are designed and manufactured for the Group's brands

Milestones in the development of the Torgiano hub:

2001 — acquisition by the Group of an existing industrial facility (2,600 square metres)

2017 — first major expansion doubled the premises of the facility (4,600 square metres), resulting in the insourcing of some production stages

2023 — additional expansion and reorganization efforts doubled the premises again (9,000 square metres), with new extensive green areas (15,000 square metres) and the completion of the production cycle

FIRST AREA

premises occupied by the **design department** and the **Prada Group Academy laboratory (3)**. These host a small-scale production facility covering all the key steps involved in product development (knitting, linking, washing and fulling phases). Here our *Master Knitters* work in cooperation with the Milan design office

SECOND AREA

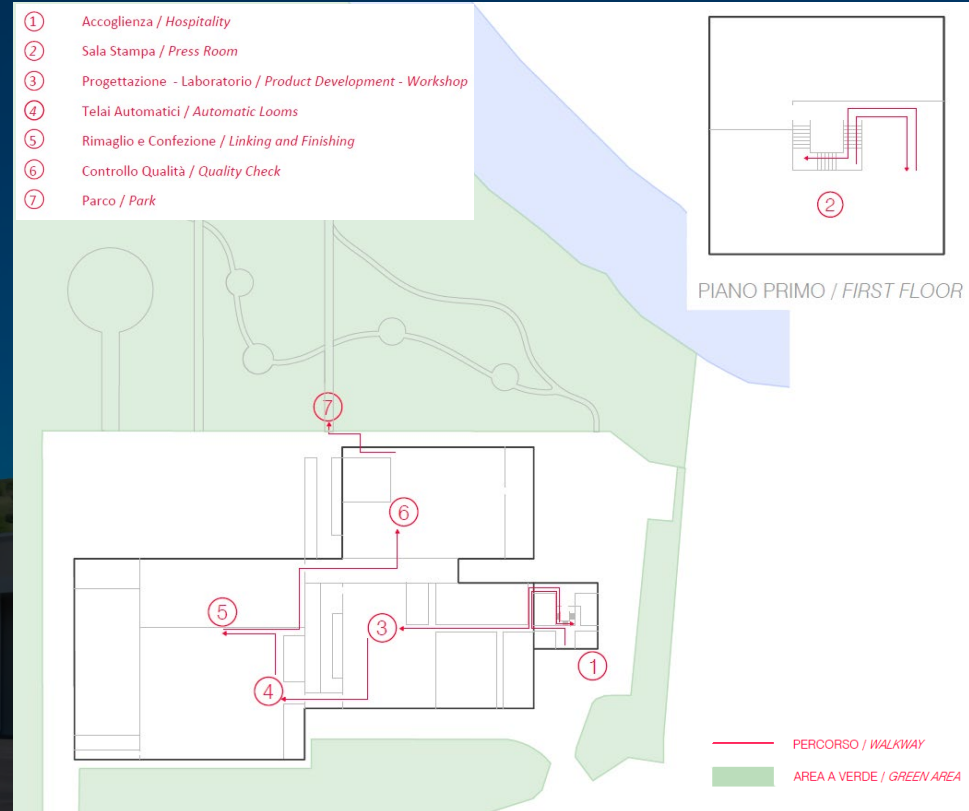
premises occupied by production units, such as the **programming office** and the **knitting machines (4)** in addition to the **linking and finishing (5)** areas

THIRD AREA

spaces for **quality control, washing and fulling (6)**

GREEN AREAS

(7), for a total of 15,000 square metres



Sustainability in Torgiano

Building characterized by a structure that allows **highly flexible management of production processes and spaces**

Park of over 15,000 square meters, provided with an equipped pedestrian path and relax areas, to better integrate the factory with the surroundings

ENERGY: Photovoltaic system and storage system enabling the plant to be 38% energy self-sufficient

WATER: Multi-purpose closed water circuit to cool the drycleaning machines and recovery of rainwater for sanitary and irrigation purposes

LEED certification process underway, with the aim of achieving Gold certification by August 2024

Prada Group Academy

Training programs to preserve manufacturing know-how in leather goods, footwear and ready-to-wear

Dedicated premises in Tuscany, Marche and Umbria facilities

In 2023, **143 young people** were trained, of which **110 were hired** in Italy (77%)

A new edition of the Prada Group Academy in **Torgiano** will start in **September 2024**

Investments in Prada Group industrial facilities 1/2

From 2019 to the end of 2022 a total of **€210 million** was invested in enhancing the industrial structure of the Group

In 2023, around **€60 million** was invested in vertical integration, the progressive insourcing of some stages of the production process and the acquisition of strategic skills

Additional investments of around **€60 million** are planned in 2024
